About the eBook Every business keeps confidential or sensitive information. Data breaches, in which confidential information is either stolen or leaked, are increasingly common. It is impossible to completely prevent them; no business is immune. Data breaches can happen to B2B or B2C companies, and consist of leaks of personally identifiable information (PII) or simply sensitive, confidential, or proprietary data. Under current laws in the United States, a data breach or spill of any magnitude involving PII triggers a range of legal obligations. An organization may have statutory obligations to disclose a data breach to its customers, or even obligations to disclose to its business partners if their data has been compromised. When a data breach occurs, there is cascading series of decisions to make irrevocable decisions which must be made quickly and with imperfect information. These decisions cannot be outsourced or delegated. It is essential, therefore, for every CEO to have an understanding of his or her company's technology organization, where its data resides, and how his company moves information around the company. Moreover, it is critical that a CEO think ahead of time about the series of recurring decisions he or she must make when responding to data spills or breaches. By training management to be aware of these issues so as to assist the CEO, understanding concepts such as security by design and privacy by design, and ensuring that the Company has a bevy of competent subject-matter experts at its disposal, a CEO can ensure that, should a data breach emergency occur, his or her Company will be properly equipped to handle it.
