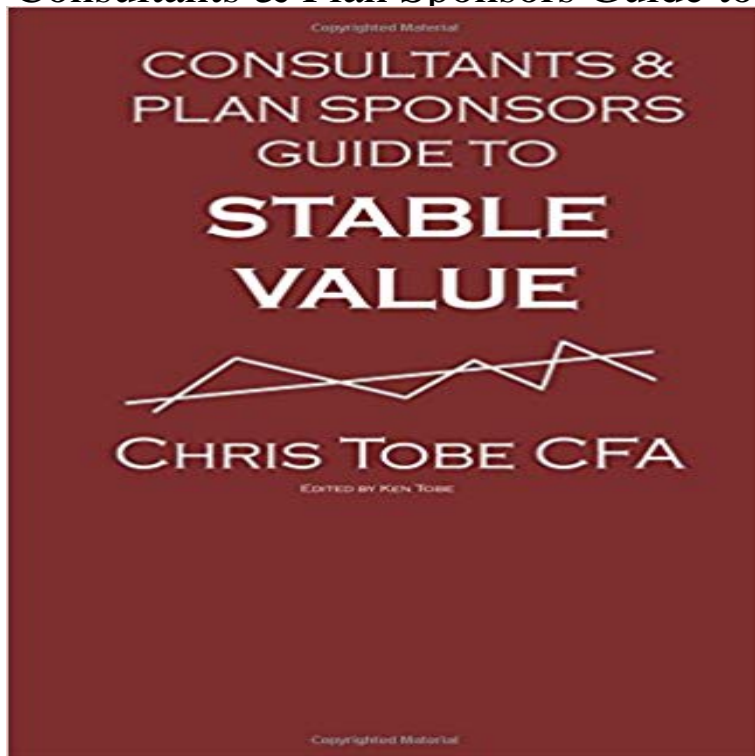


## Consultants & Plan Sponsors Guide to Stable Value
