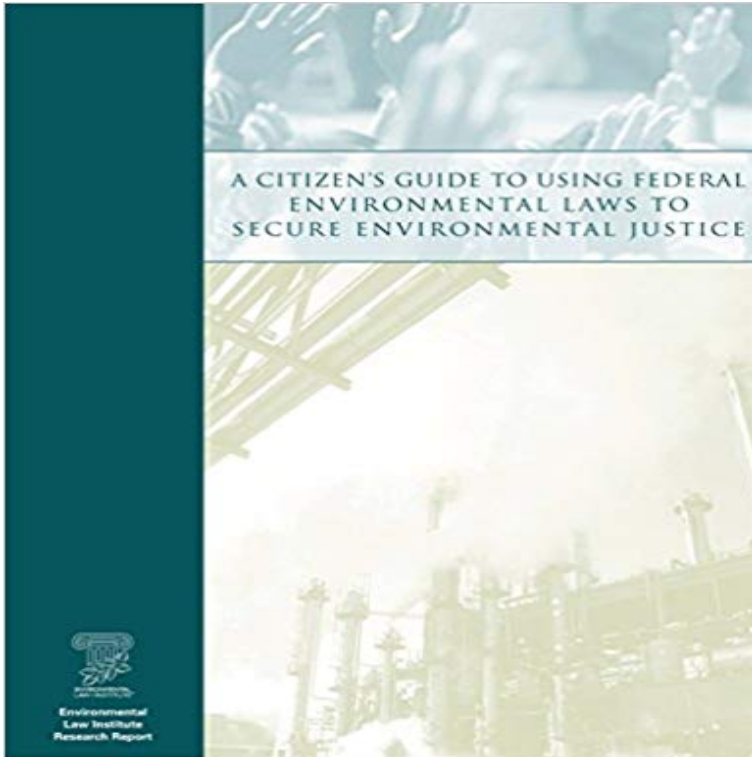


# A Citizens Guide to Using Federal Environmental Laws to Secure Environmental Justice
