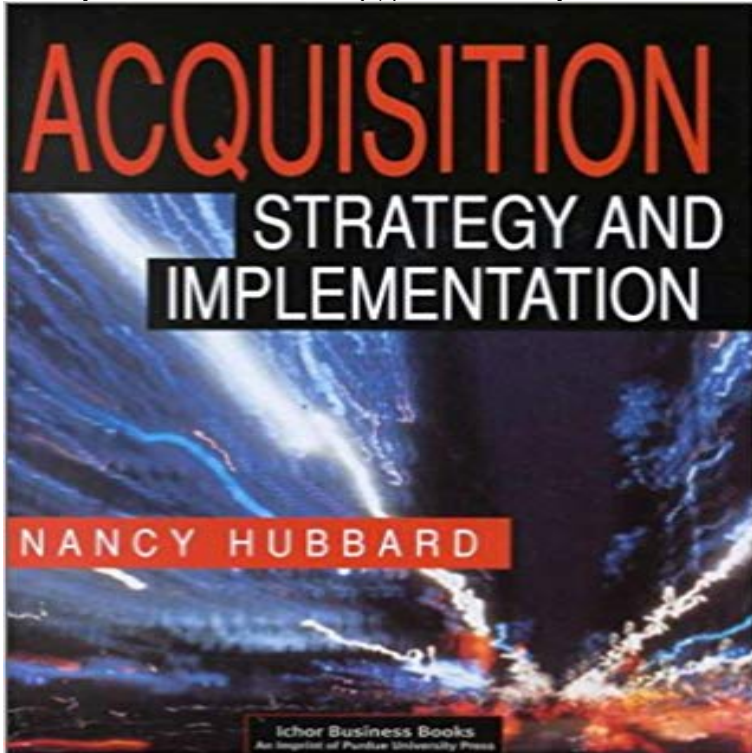


## Acquisition Strategy and Implementation
