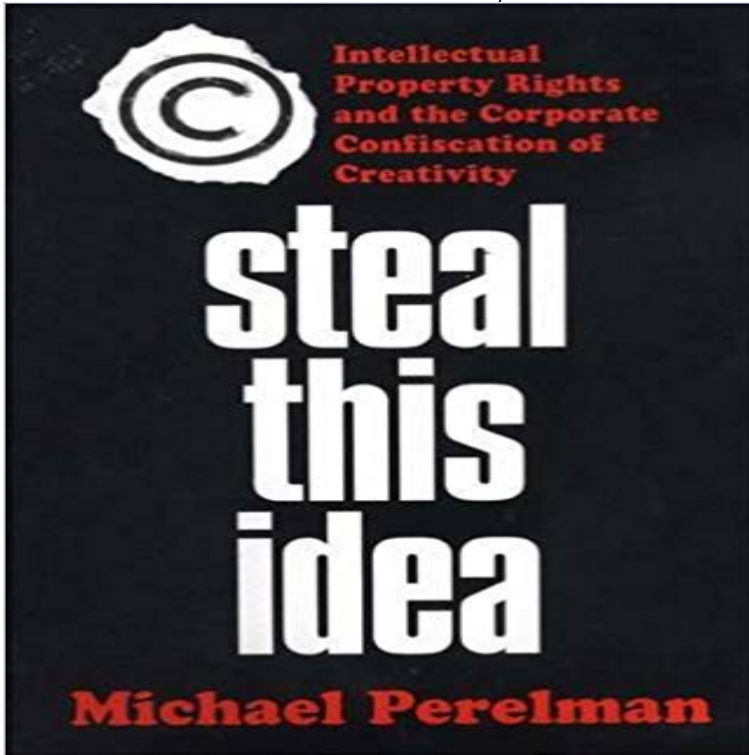


Steal This Idea: Intellectual Property Rights and the Corporate Confiscation of Creativity
