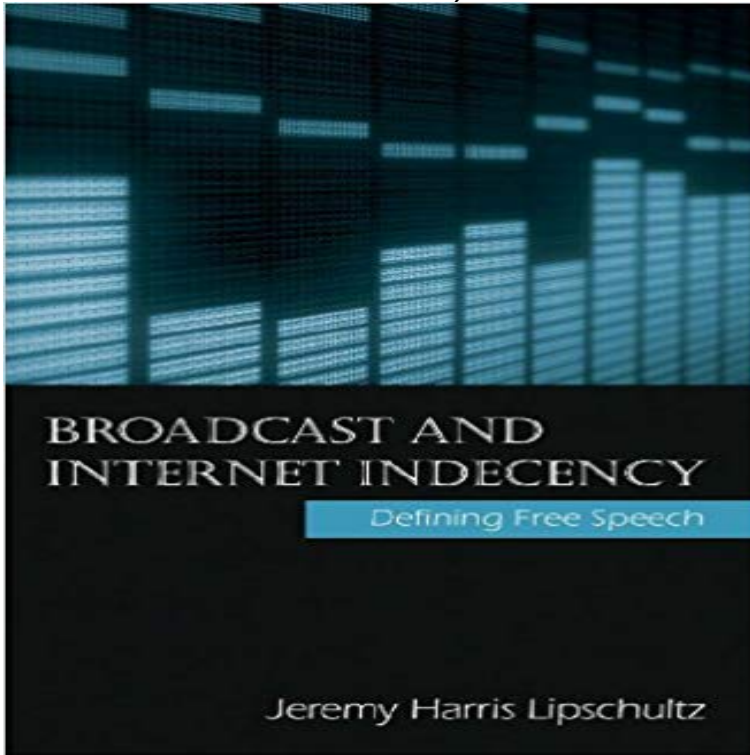


## Broadcast and Internet Indecency: Defining Free Speech (Routledge Communication Series)
