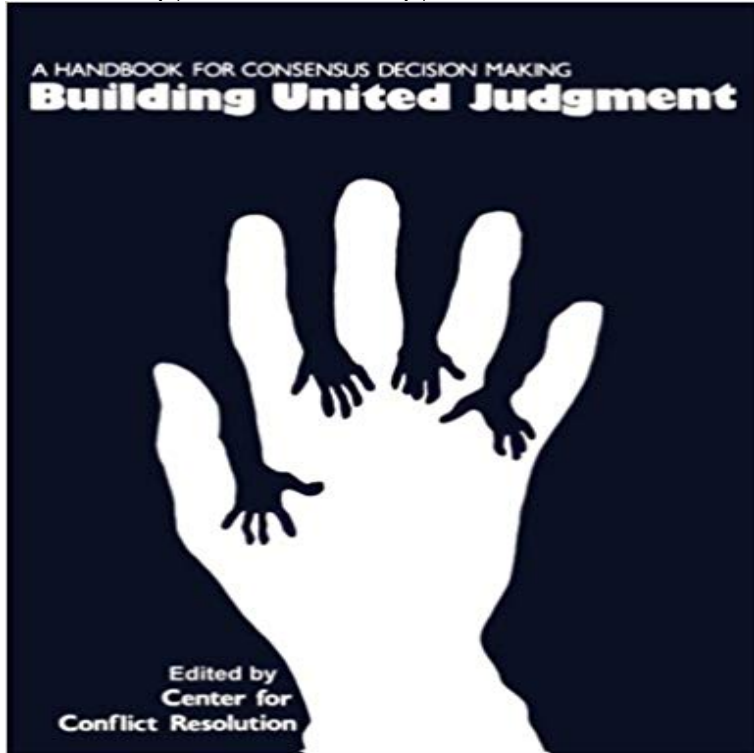


# Building United Judgment: A Handbook for Consensus Decision Making
