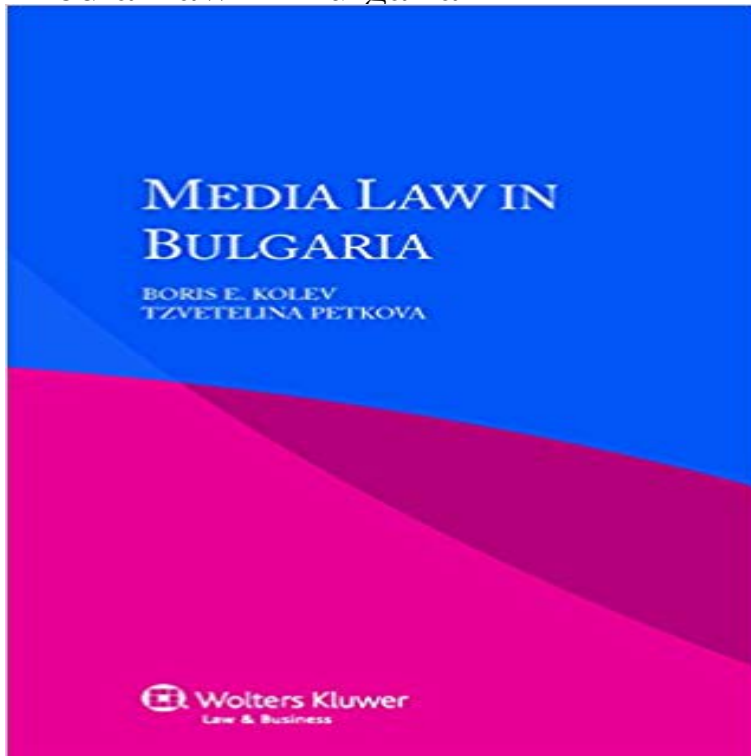


## Media Law in Bulgaria
