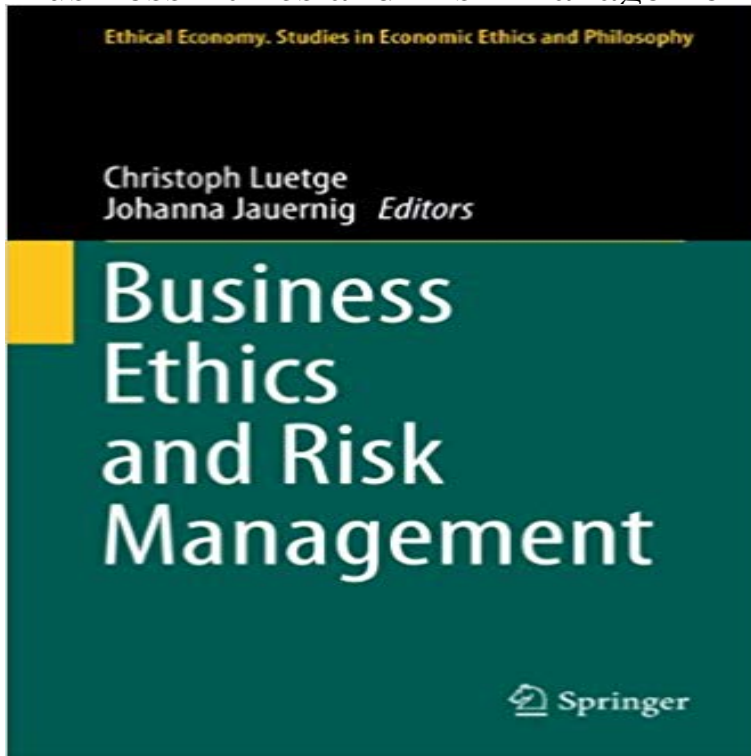


Business Ethics and Risk Management: 43 (Ethical Economy)

The main issues examined in the book are the financial crisis and its implications for business ethics. The book discusses unethical behaviour as a reputational risk (e.g., in the case of Goldman Sachs) and the question is raised as to what extent the financial crisis has changed the banks entrepreneurial strategy.
