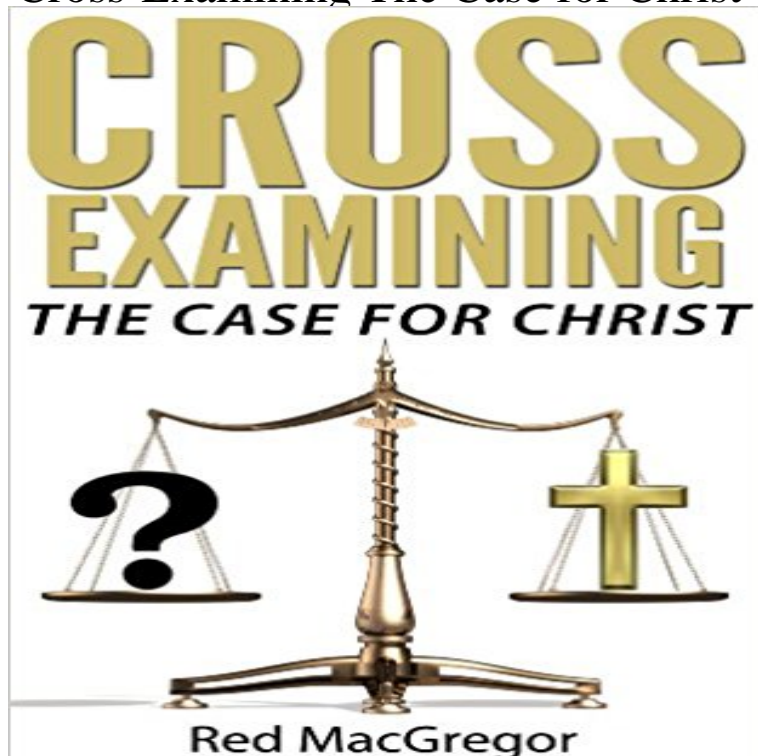


Cross-Examining The Case for Christ
