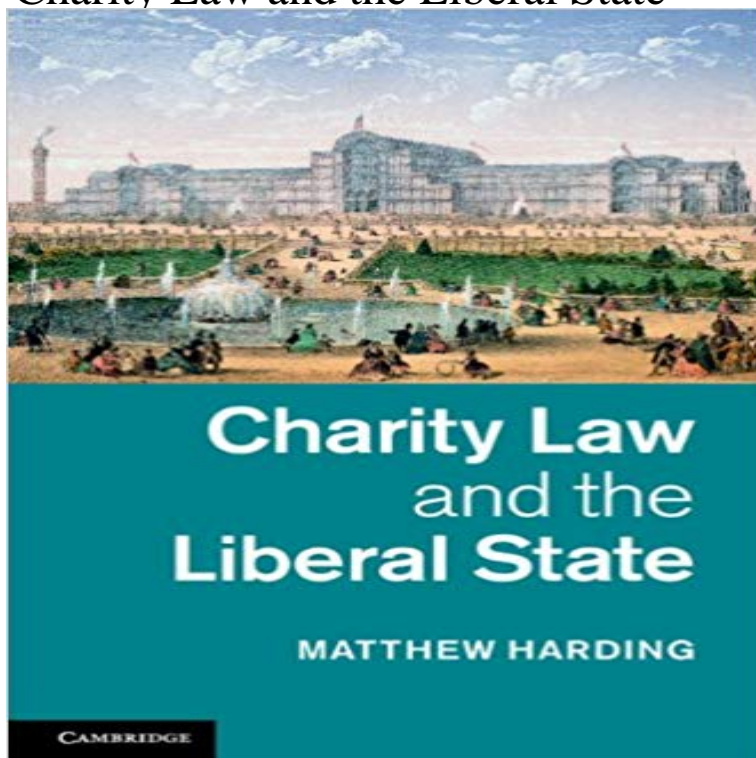


Charity Law and the Liberal State
