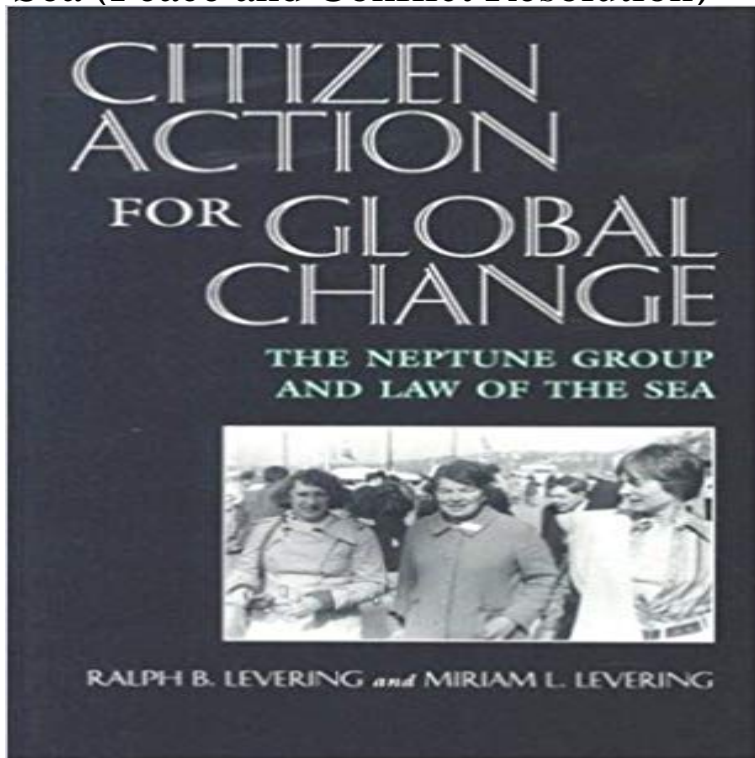


Citizen Action For Global Change: The Neptune Group and Law of the Sea (Peace and Conflict Resolution)
