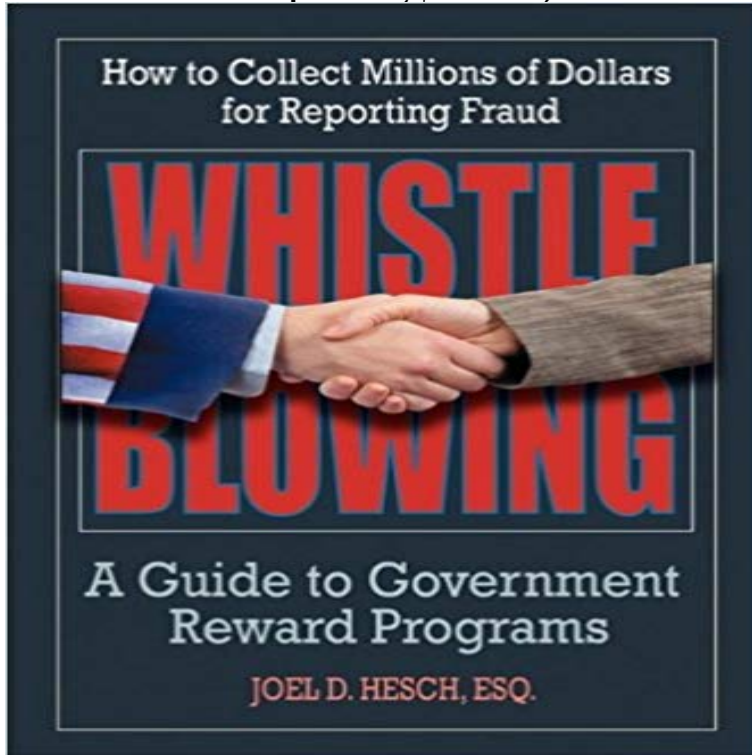


## Whistleblowing: A guide to government reward programs (how to collect millions for reporting fraud)
