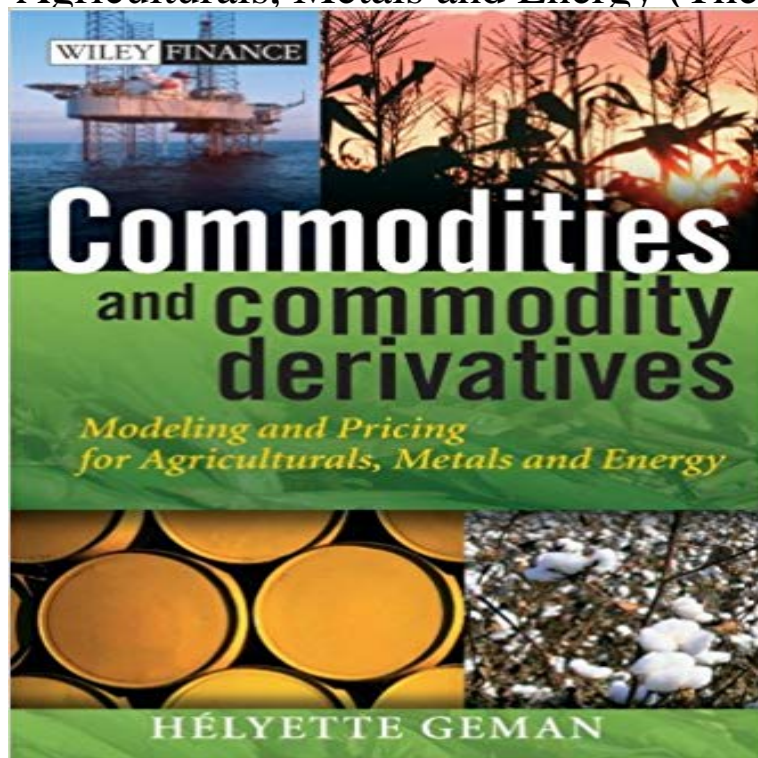


# Commodities and Commodity Derivatives: Modeling and Pricing for Agriculturals, Metals and Energy (The Wiley Finance Series)
