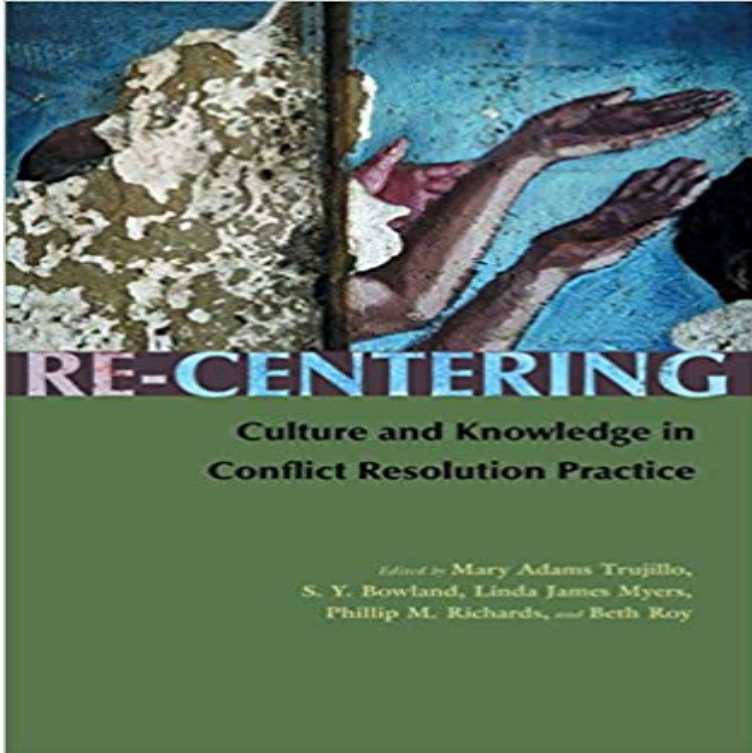


## Re-Centering Culture and Knowledge in Conflict Resolution Practice (Syracuse Studies on Peace and Conflict Resolution)

By melding these varied approaches, the authors seek to inspire activism for social justice in today's multicultural society.
