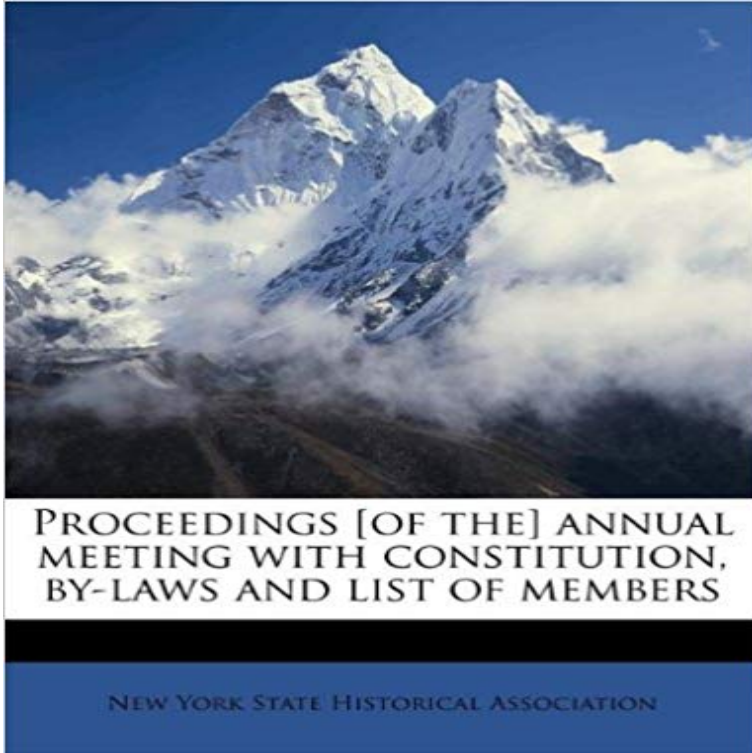


# Proceedings [of the] annual meeting with constitution, by-laws and list of members
