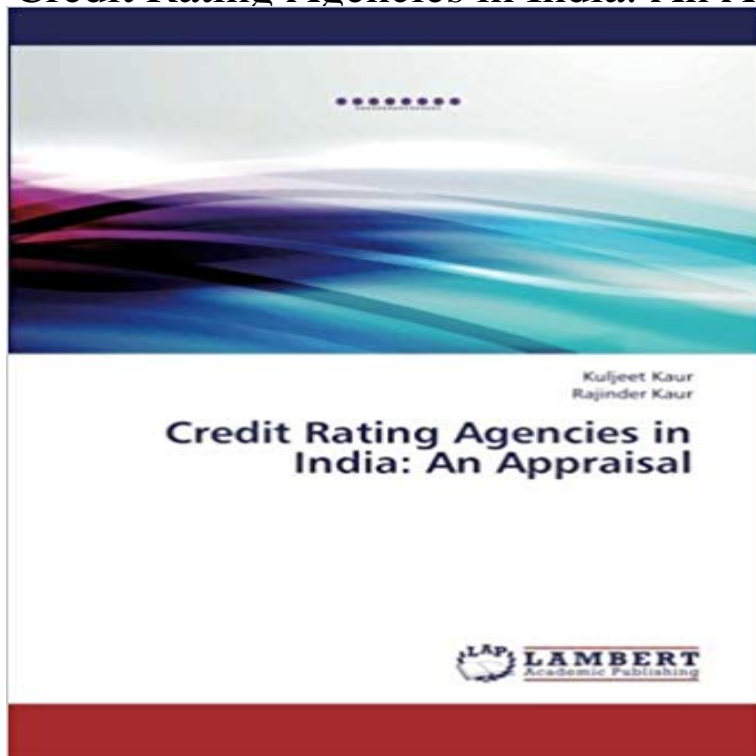


## Credit Rating Agencies in India: An Appraisal
