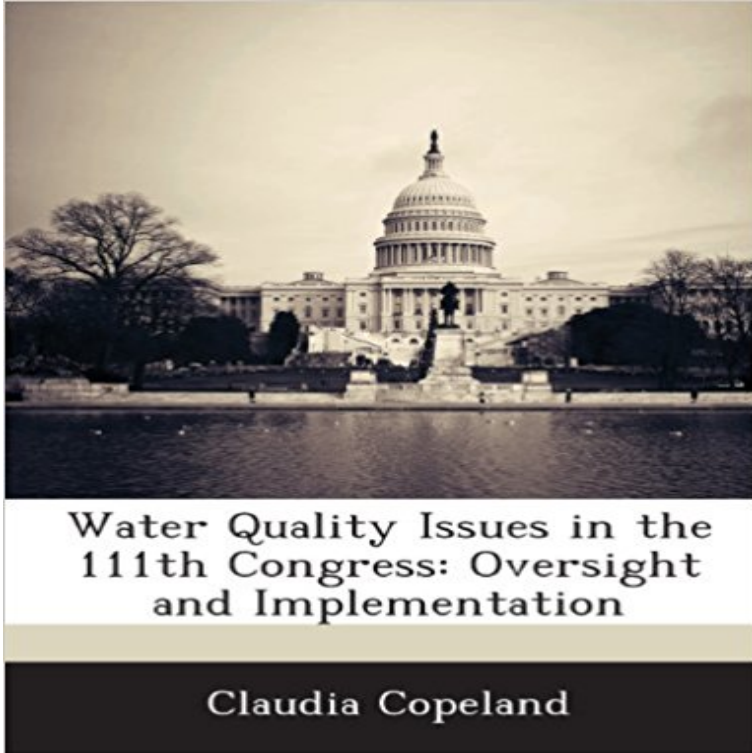


Water Quality Issues in the 111th Congress: Oversight and Implementation



Although much progress has been made in achieving the ambitious goals that Congress established more than 35 years ago in the Clean Water Act (CWA) to restore and maintain the chemical, physical, and biological integrity of the nations waters, long-standing problems persist, and new problems have emerged. Water quality problems are diverse, ranging from pollution runoff from farms and ranches, city streets, and other diffuse or nonpoint sources, to toxic substances discharged from factories and sewage treatment plants.
