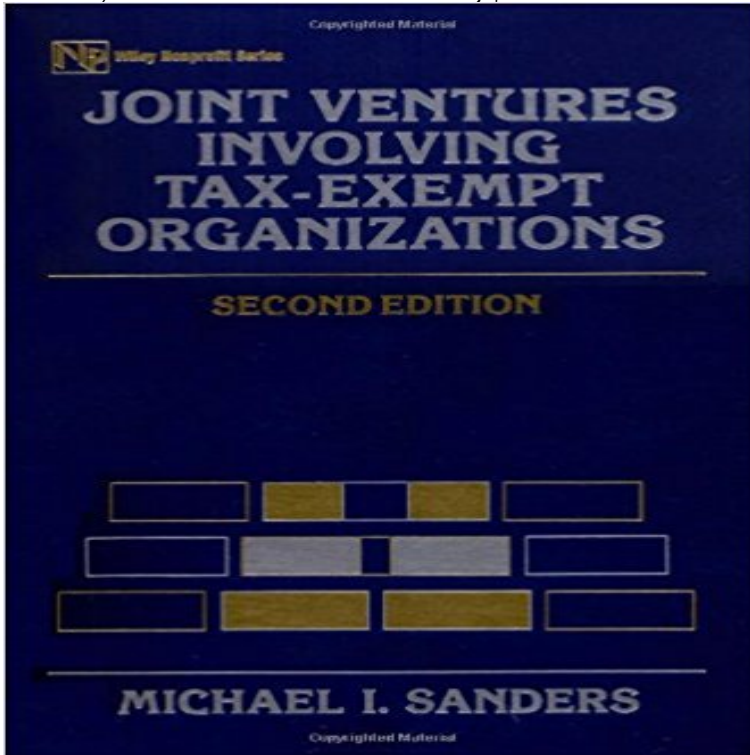


# Joint Ventures Involving Tax-Exempt Organizations (Wiley Nonprofit Law, Finance and Management Series)
