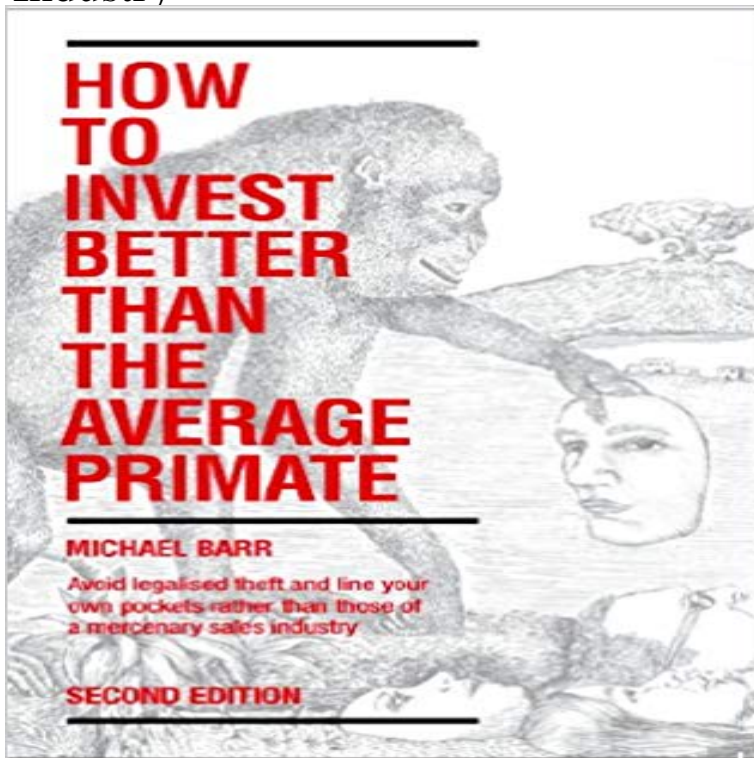


How to Invest Better Than the Average Primate: Avoid Legalised Theft and Line Your Own Pockets Rather Than Those of a Mercenary Sales Industry

This book will help you to understand how to build your own very simple but effective investment portfolio in a way not possible in the UK until recent times. Each chapter of the book presents a simple message. Detailed information for the more inquisitive investor can be found in the

appendix. This book will give you the knowledge to take control of your investments, and to cut your investment costs by three-quarters. If you do not have the time or inclination to run your own portfolio, or your affairs are complicated, you will learn what questions to ask when selecting a good adviser.
