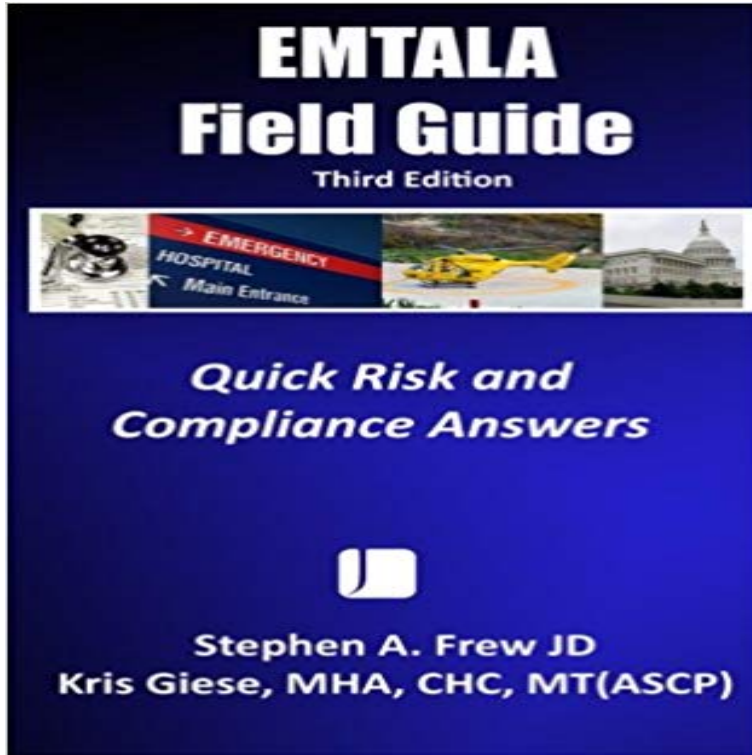


EMTALA Field Guide -- 3rd Edition: Quick Risk and Compliance Answers
