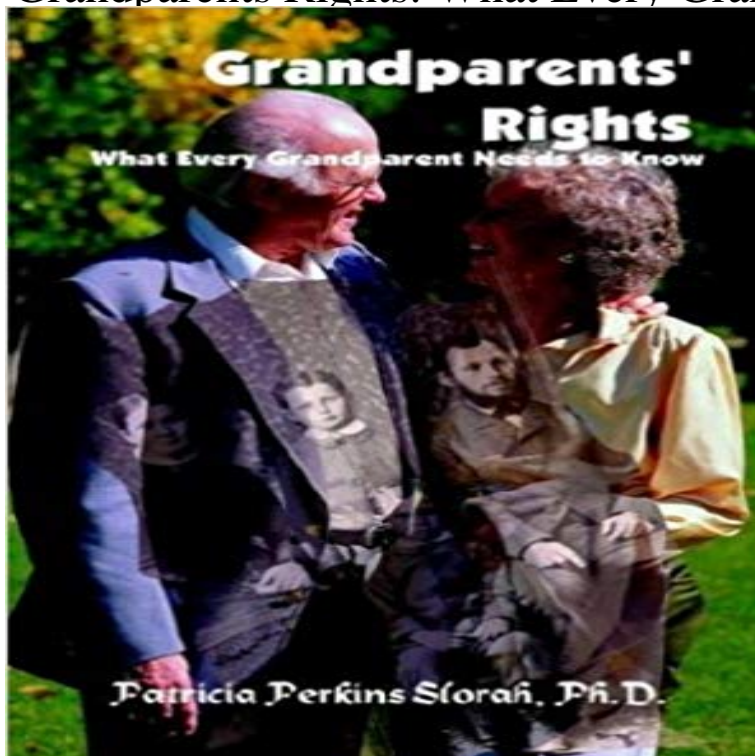


## Grandparents Rights: What Every Grandparent Needs to Know
