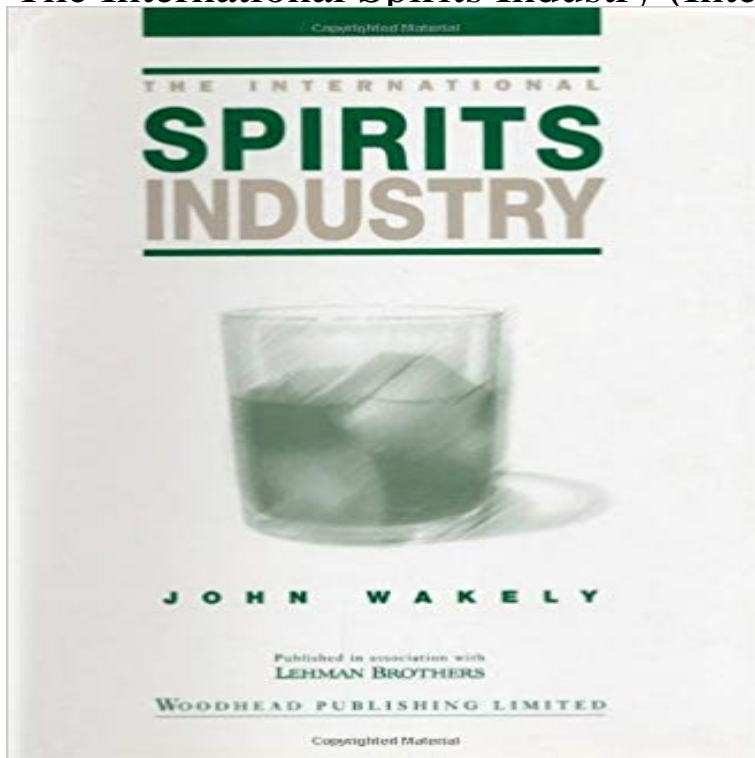


The International Spirits Industry (International Trade)
