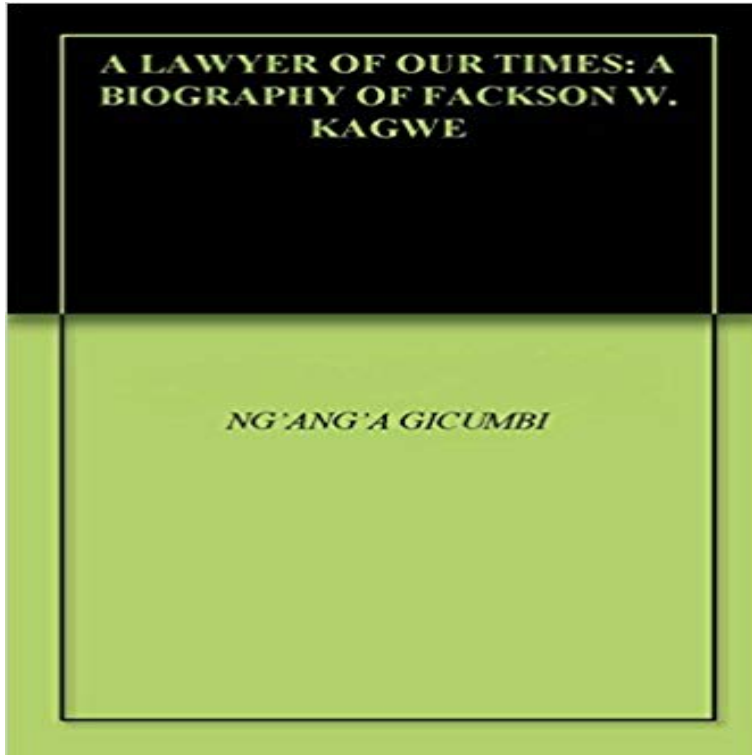


# A LAWYER OF OUR TIMES: A BIOGRAPHY OF FACKSON W. KAGWE
