

## Implementing Cost Effective Controls



Control and Compliance and their associated costs have become focus areas of CIOs and CISOs. With the advent of Sarbanes-Oxley and other legislation, information technology professionals are being asked to respond to increase regulatory and compliance considerations in a timely and cost-effective manner. Having the right control at the right place, at the right time, and for the right cost, improves the risk posture and overall profitability of the organization. Without them, companies are exposed to fines, penalties, brand damage, and decreased customer perception of their offerings. Having the right controls in place also establishes the foundational layer of IT General Controls upon which other application and business controls are reliant upon. This paper outlines a basic approach to assessing the current culture and control environment, and identifying means to assess and manage it, which will have a positive impact on the cost of controls.
