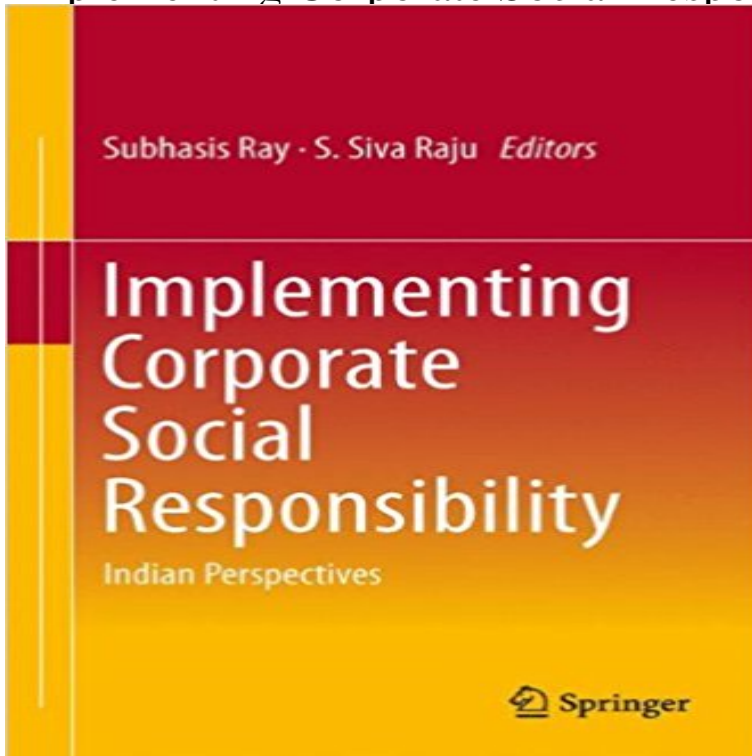


Implementing Corporate Social Responsibility: Indian Perspectives
