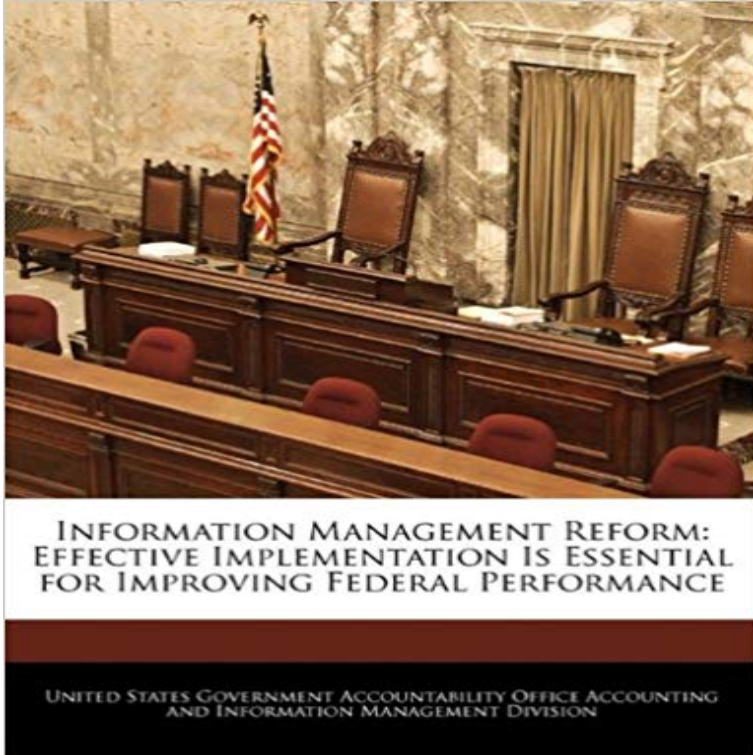


Information Management Reform: Effective Implementation Is Essential for Improving Federal Performance
