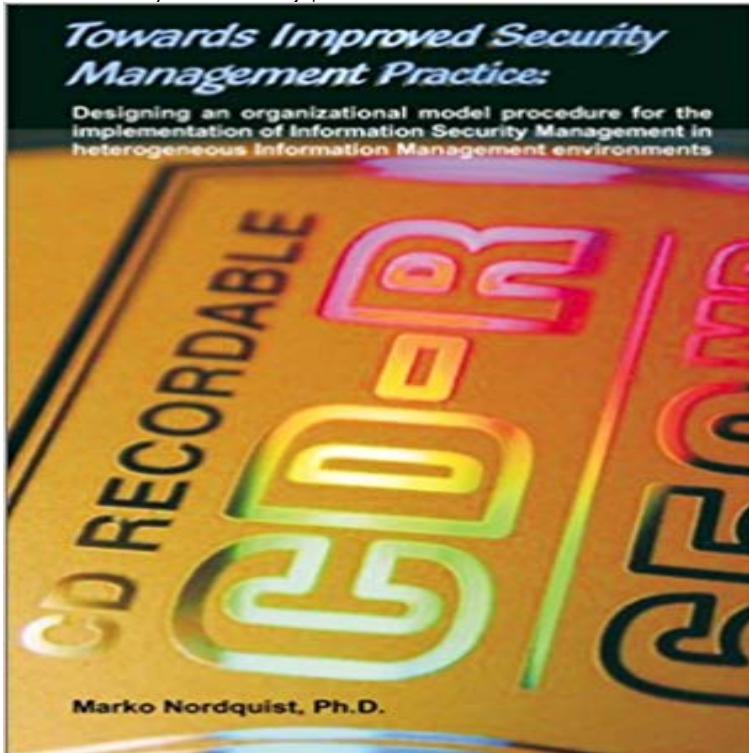


Towards Improved Security Management Practice: Designing an organizational model procedure for the implementation of Information Security Management ... Information Management environments
