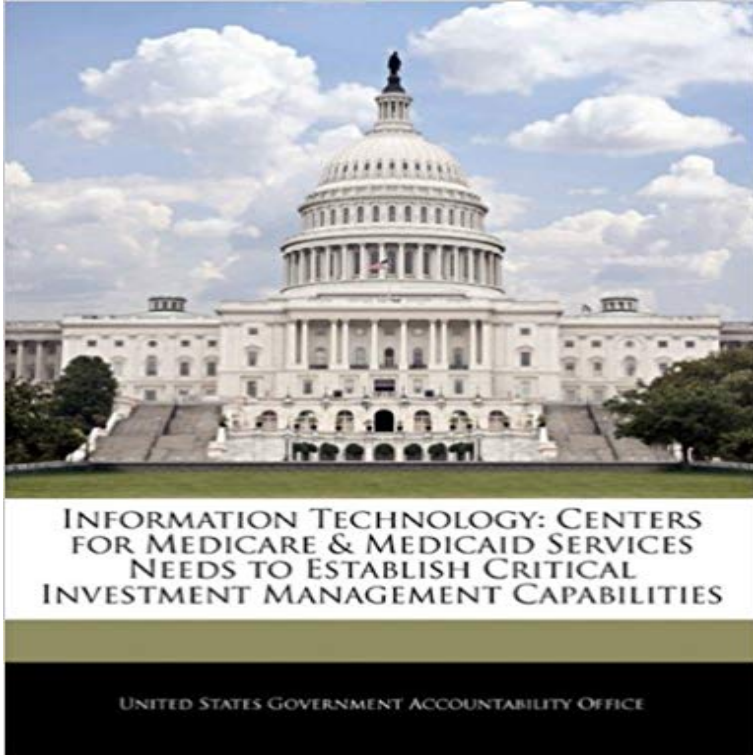


# Information Technology: Centers for Medicare & Medicaid Services Needs to Establish Critical Investment Management Capabilities
