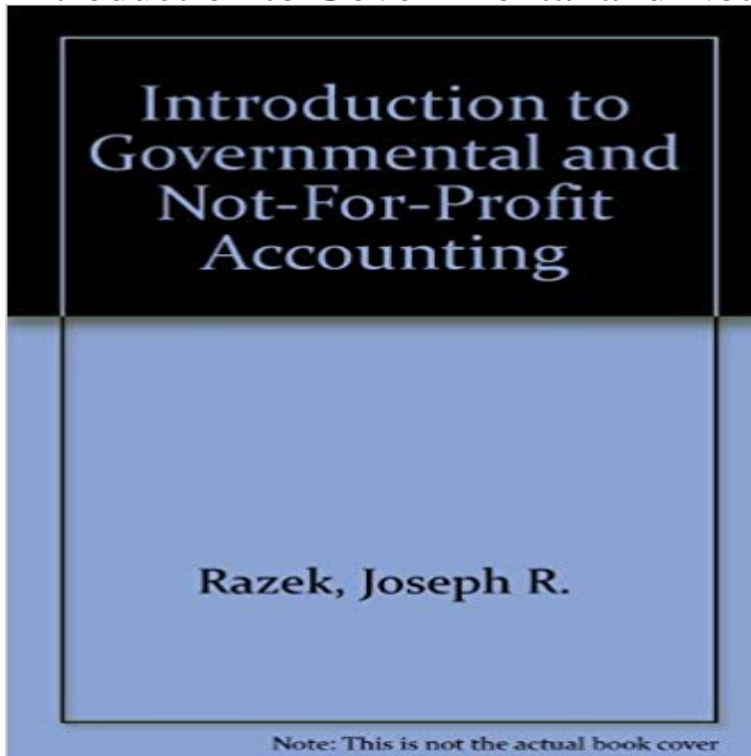


# Introduction to Governmental and Not-For-Profit Accounting
