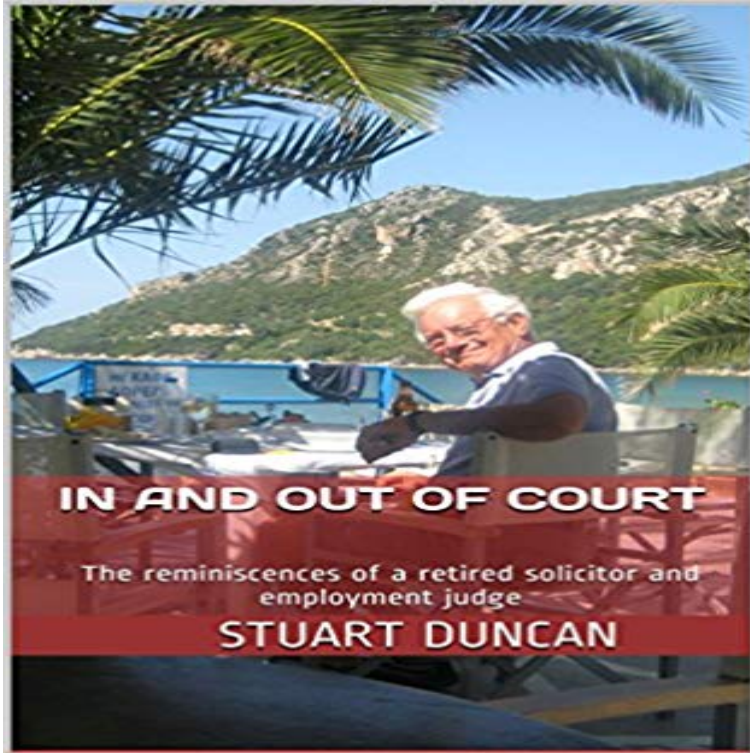


In and Out of Court: The reminiscences of a retired solicitor and employment judge
