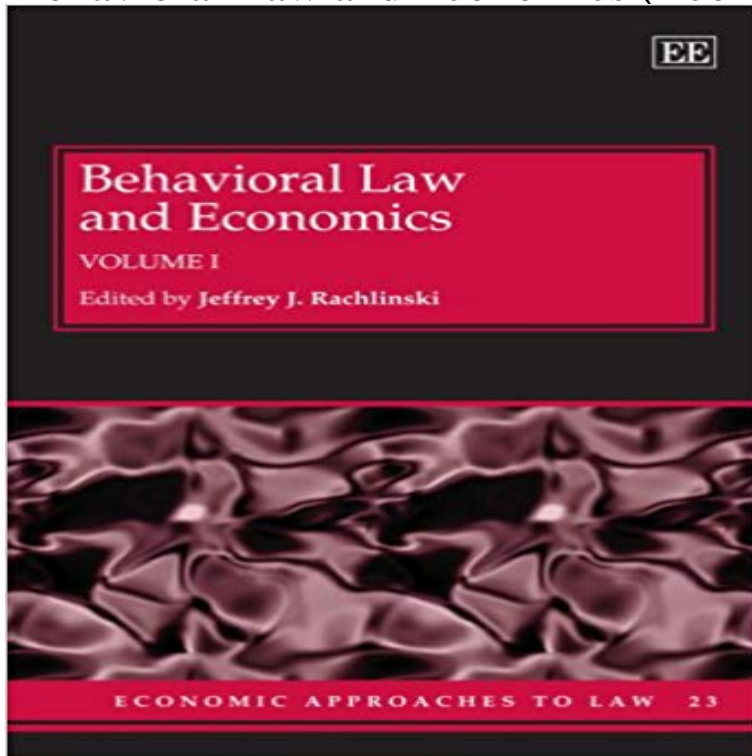


## Behavioral Law and Economics (Economic Approaches to Law)
