Poverty and need are indeed the greatest polluters, It is recognized widely that population growth is essentially the result of poverty and lack of education. Governmental awareness of environmental issues is evident. The earliest laws aimed at controlling air pollution were the Bengal Smoke Nuisance Act of 1905 and Bengal Smoke Nuisance Act of 1912. In 1912 the Central Government enacted a broader Wild Birds and Animal Protection Act. The River Boards established under the River Boards Act of 1956 for the regulation and development of inter-state rivers and river valleys were empowered to prevent water pollution. Environmental regulation got fresh impetus after the UN Conference of Human Environment in 1972. Consequently, a National Committee on Environmental Planning and Co-ordination (NCEPC) was established as an apex advisory body on all environmental matter. On the recommendations of the Tiwari committee, a separate department of environment was established at the Centre on November 1.
