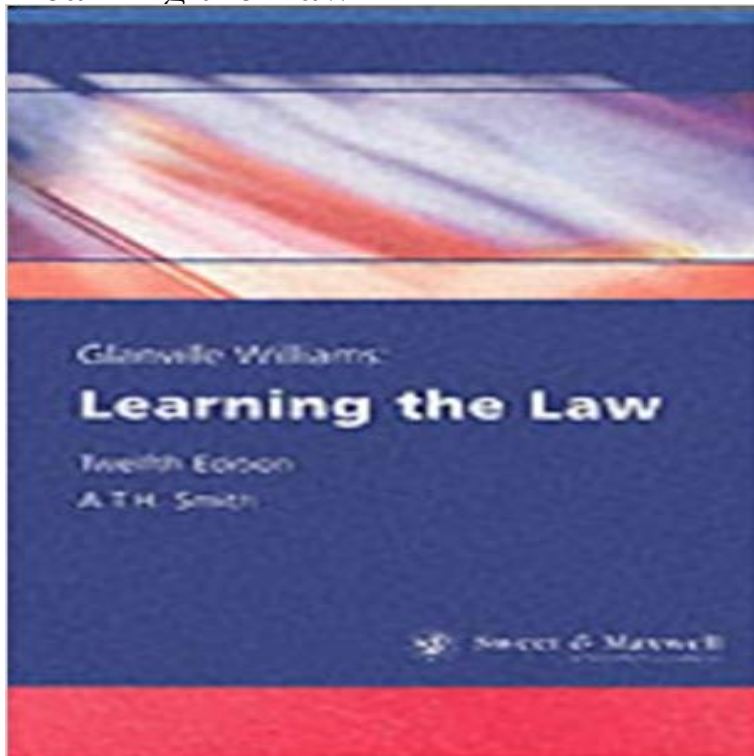


Learning the Law
