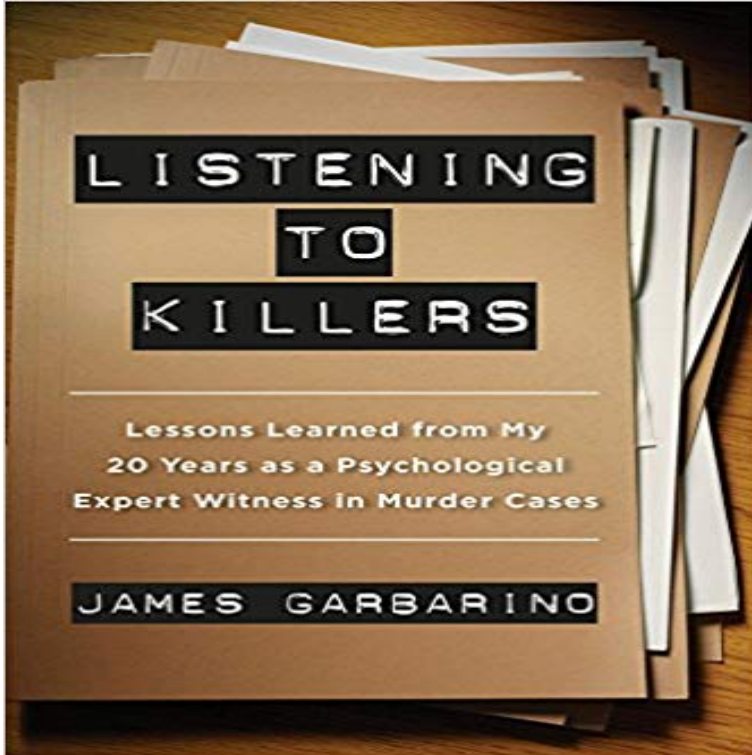


Listening to Killers: Lessons Learned from My Twenty Years as a Psychological Expert Witness in Murder Cases
