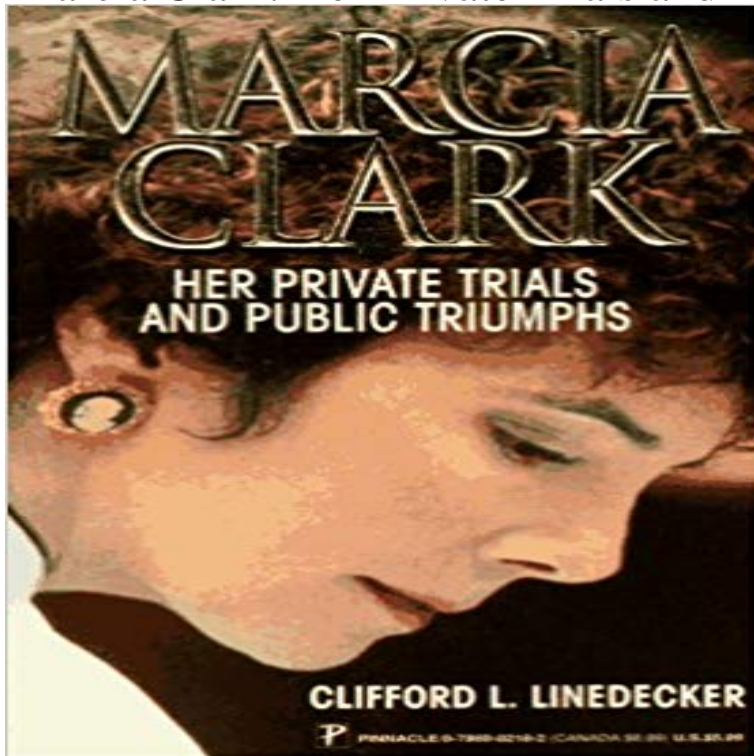


Marcia Clark: Her Private Trials and Public Triumphs
