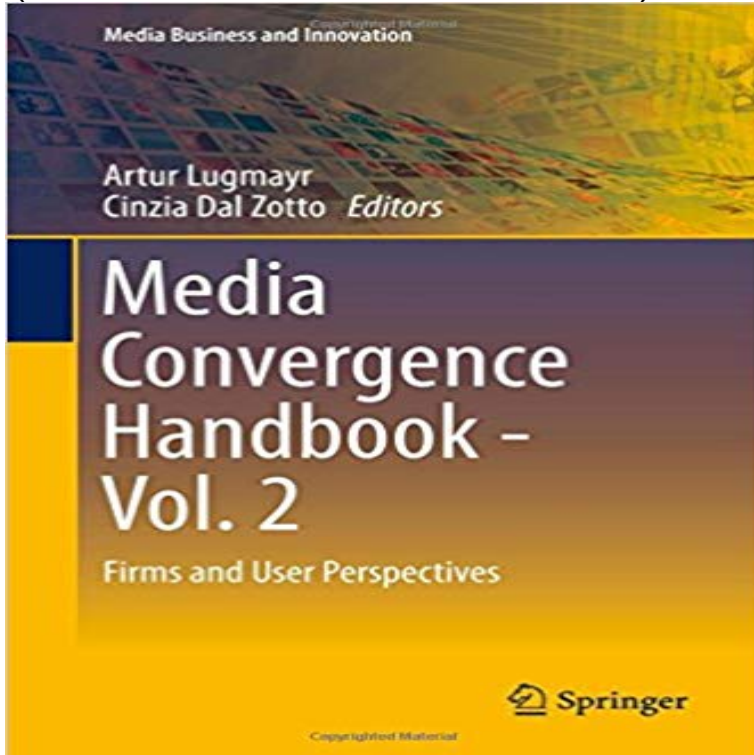


Media Convergence Handbook - Vol. 2: Firms and User Perspectives (Media Business and Innovation)
