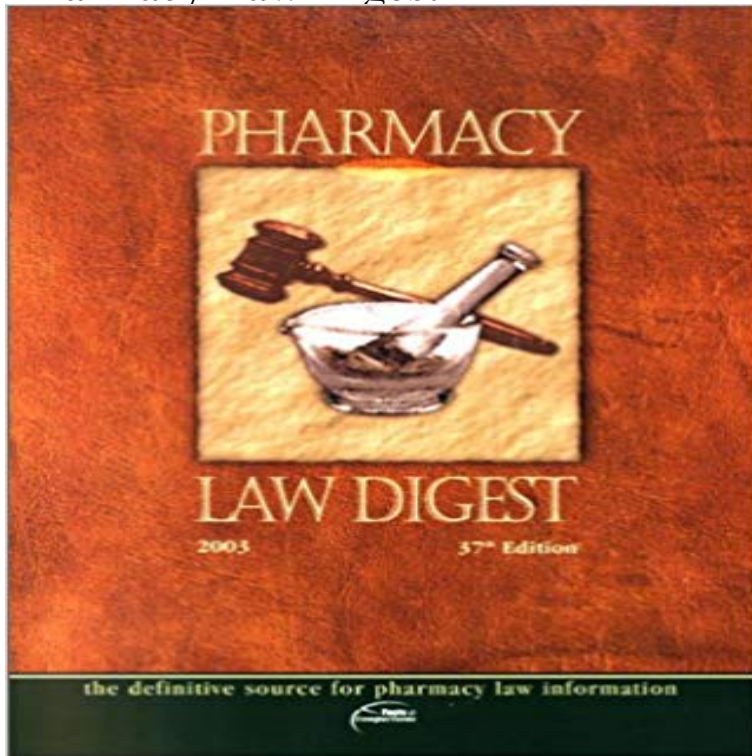


Pharmacy Law Digest
