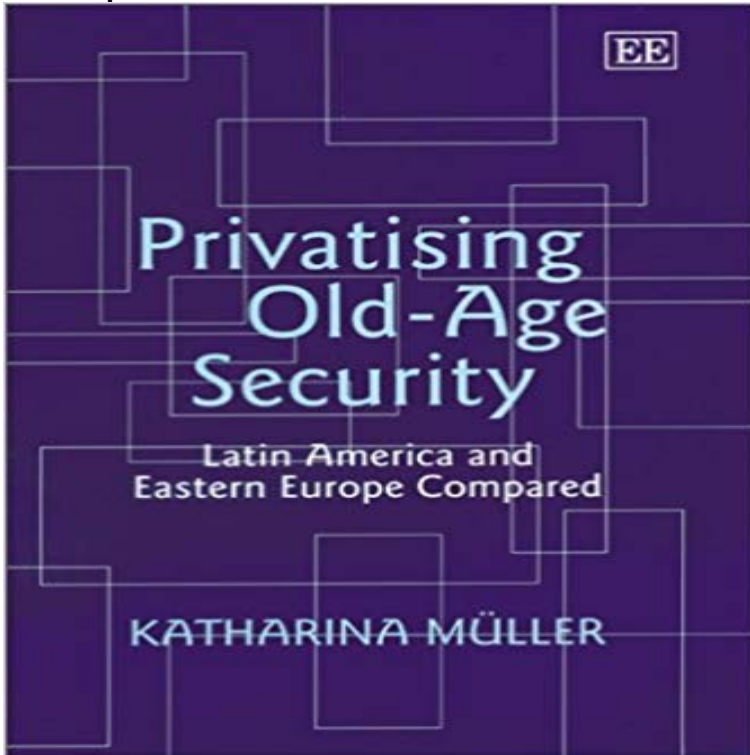


Privatising Old-Age Security: Latin America and Eastern Europe Compared
