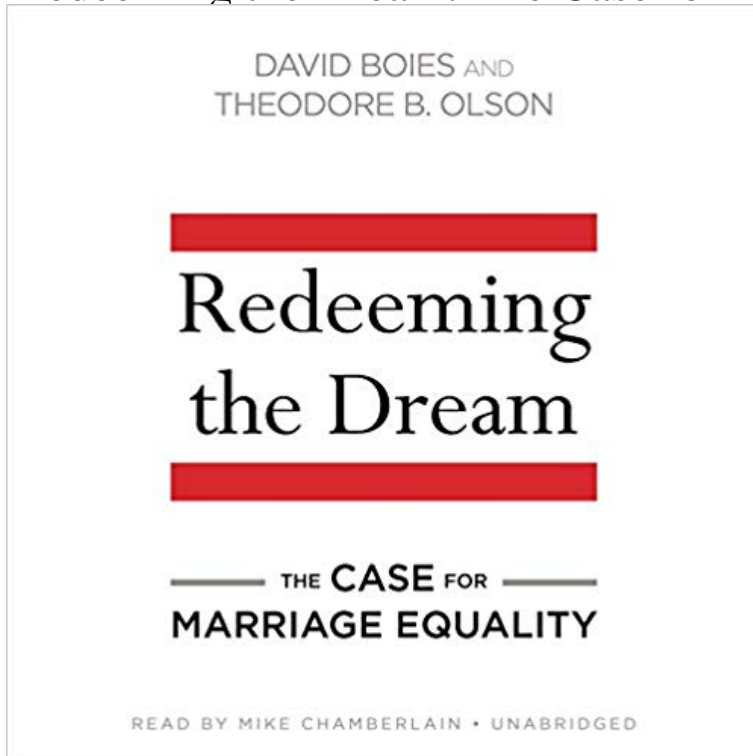


# Redeeming the Dream: The Case for Marriage Equality
