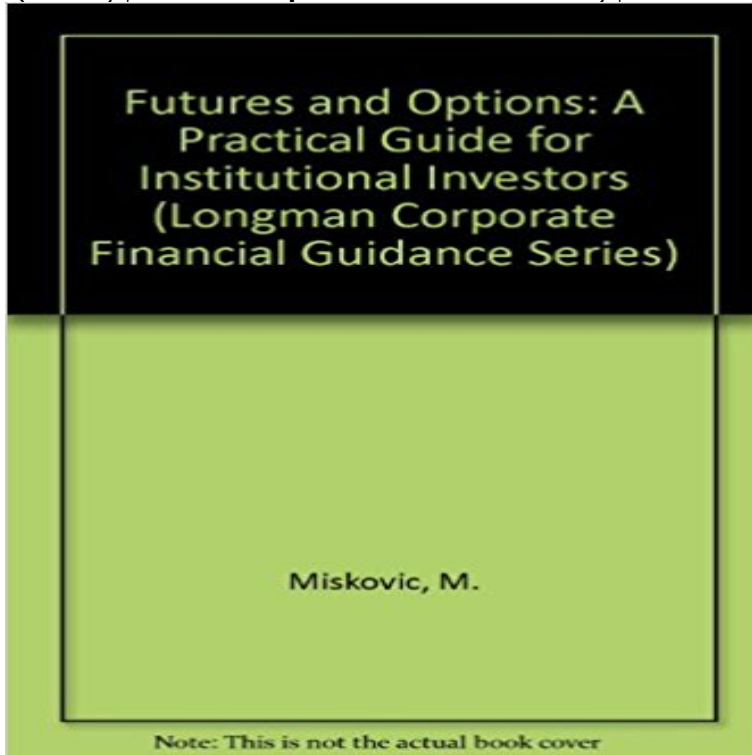


Futures and Options: A Practical Guide for Institutional Investors (Longman corporate financial guidance series)
