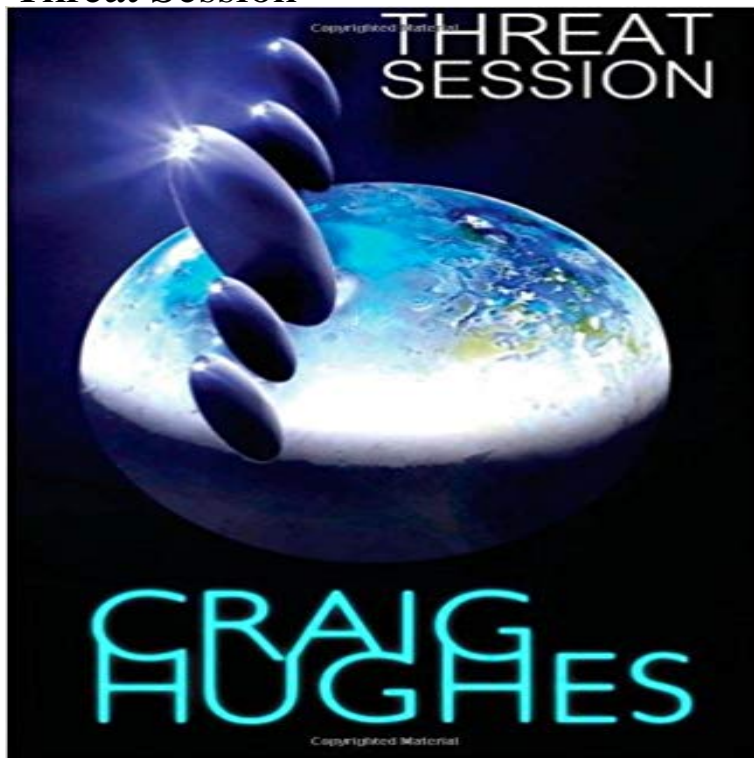


## Threat Session
