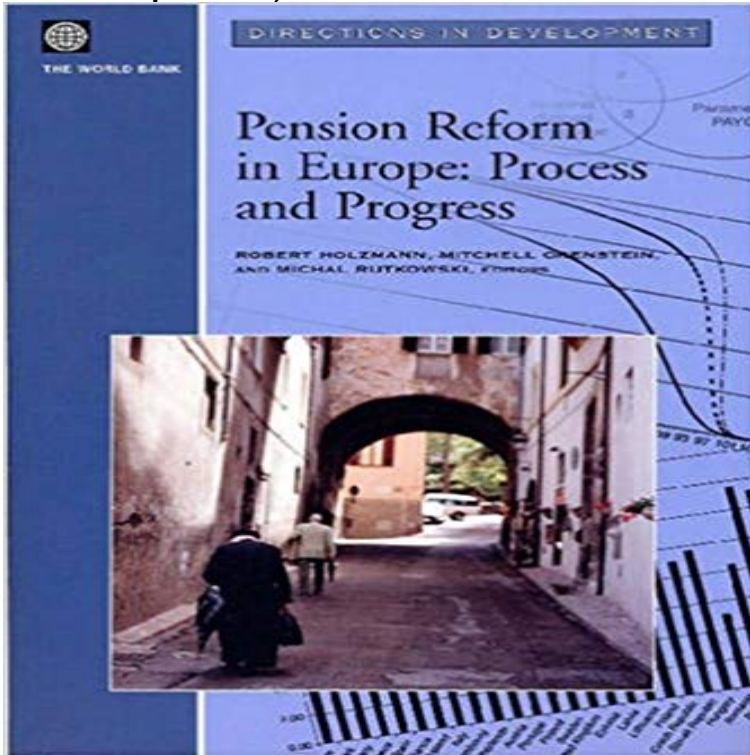


# Pension Reform in Europe: Process and Progress (Directions in Development)
