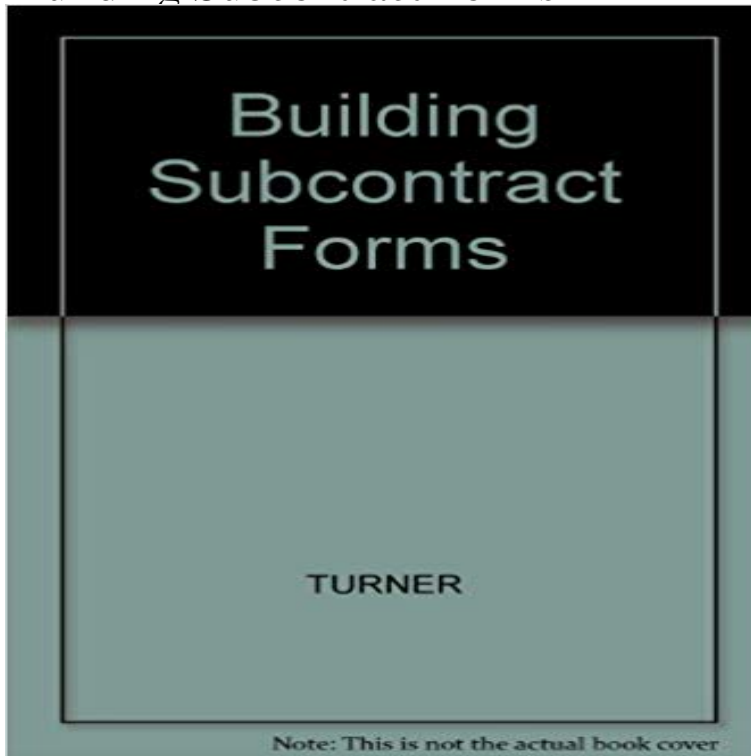


Building Subcontract Forms
