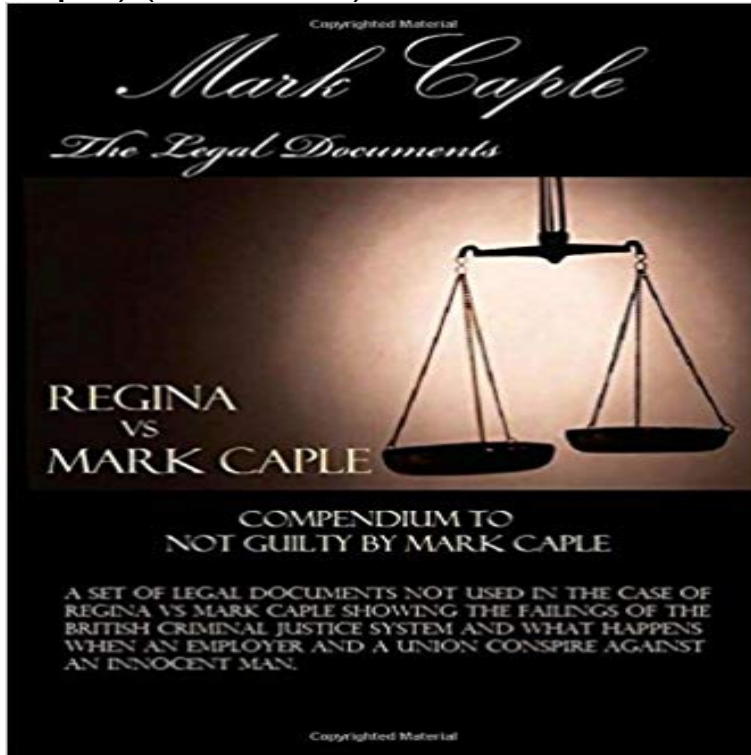


## The Legal Documents: Compendium to Not Guilty (not guilty mark caple) (Volume 3)
