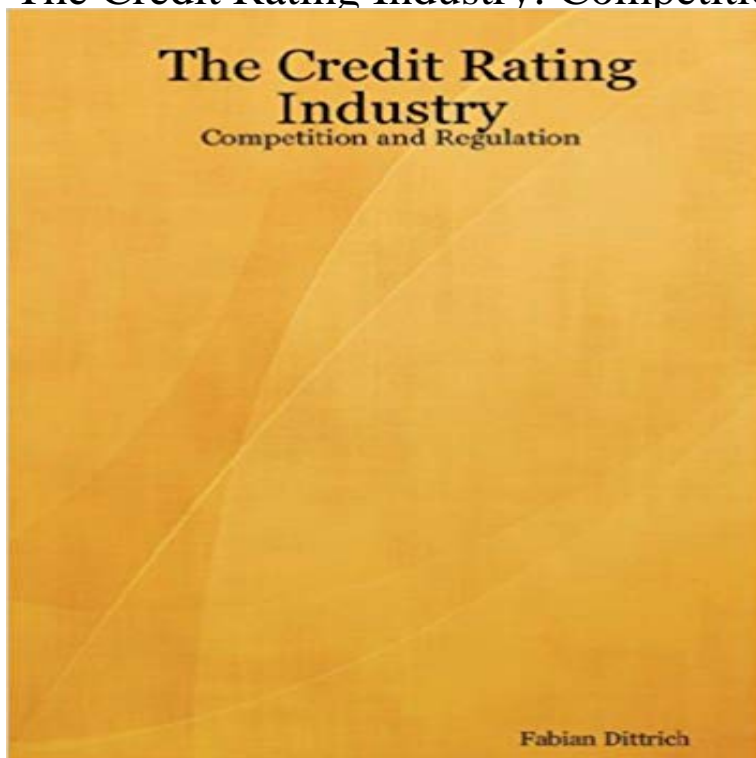


The Credit Rating Industry: Competition and Regulation



This study provides a comprehensive analysis of credit rating economics and draws conclusions on the nature of regulation.
