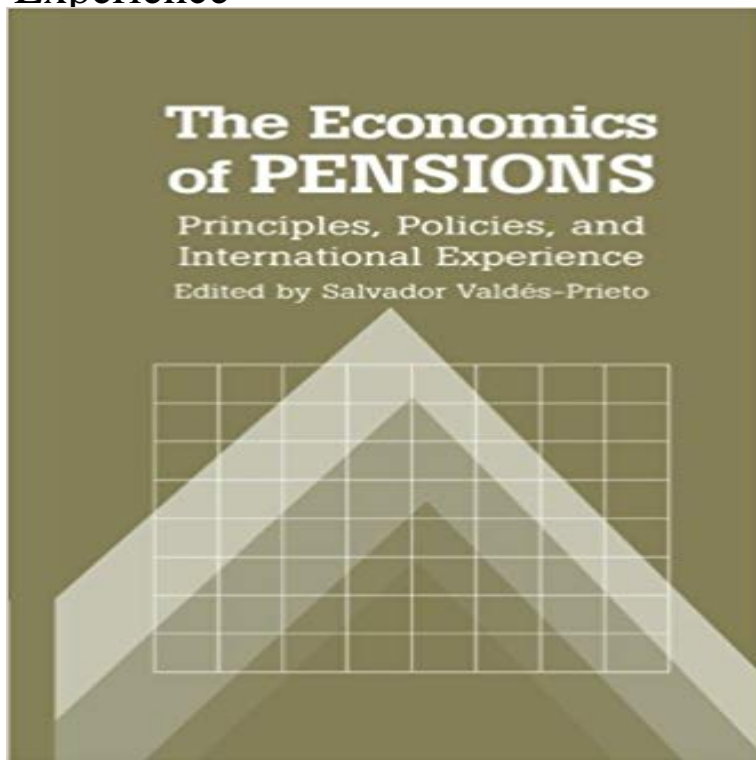


The Economics of Pensions: Principles, Policies, and International Experience
