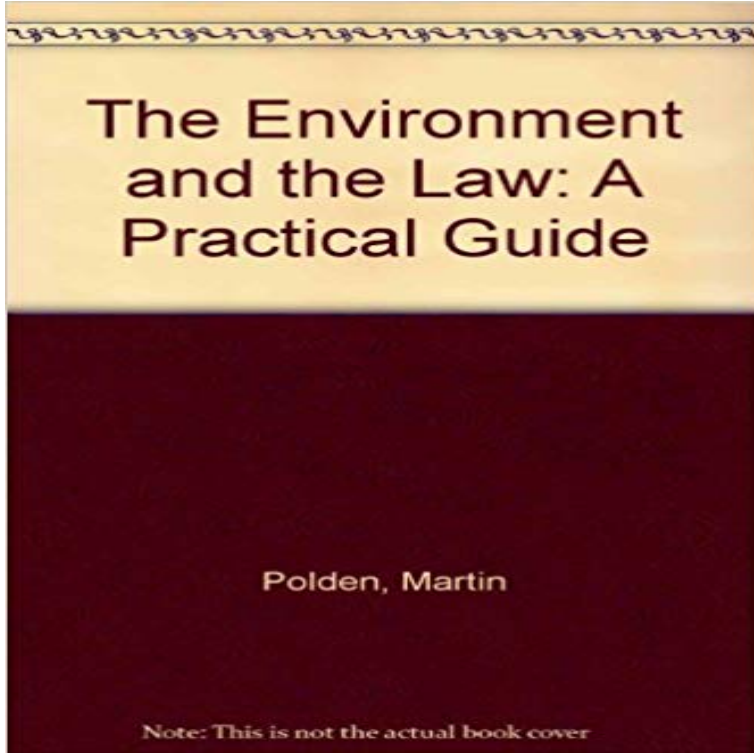


## The Environment and the Law: A Practical Guide
