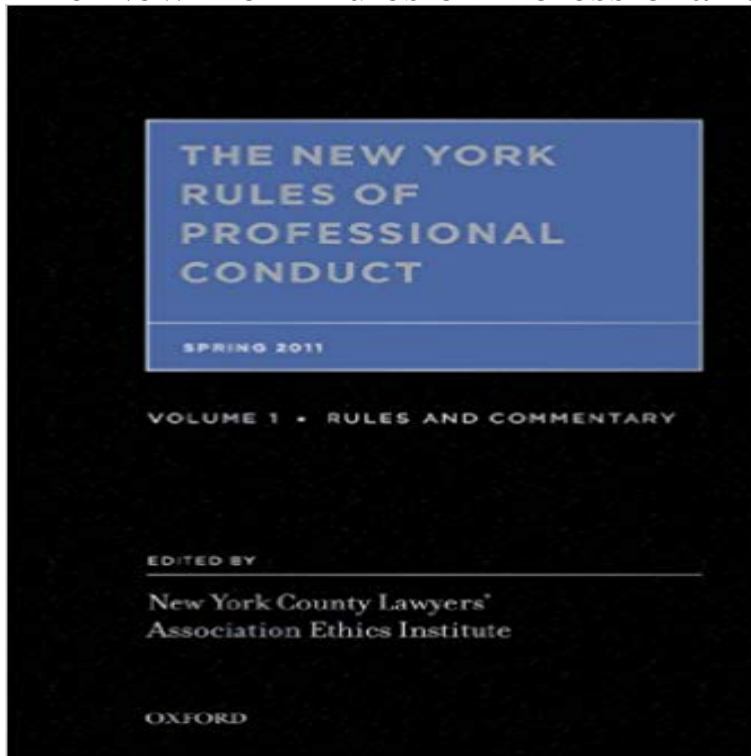


The New York Rules of Professional Conduct: Spring 2011
