Information governance is using the business strategy to apply objectivity, economies, and efficiencies of scale to the processes necessary for the management of information in the achievement of business success. The point of Information or Data Governance is to create TRUSTED data for the business. But how is that actually done? The book focuses on describing deliverables and techniques necessary to quantify and measure the Trust of information, including creating dashboards to monitor the success of the Information Management and Governance (IMG) Program as well as an overall Trust Dashboard for the enterprise.
